

Ensure Good Governance

If we look at a definition for Governance from Wikipedia we find:

The CWSS-SCM Board in 2008 determined that under Good Governance there would be four main objectives for the CWSS-SCM:

The 2011 CWSS-SCM Annual Meeting



The Marriott Gateway on the Falls was the beautiful setting chosen for the 2011 Annual Meeting of Canadian Weed Science Society/Société canadienne de malherbologie. Clarence Swanton and the rest of the Local Arrangements Committee (LAC) made sure that their colleagues from around Canada (and the U.S.) were treated to all the best that the region had to offer. The total number of attendees at the 2011 annual meeting in the Niagara Falls was 182.

So first thing on the meeting agenda was a pre-conference Wine and Scenery Tour of the region. The tour group visited different wineries in the region, did a bit of shopping at Niagara-on-the-Lake and saw some of the sights of the region.

Over 30 attendees participated in the tour. The tour guests were able to taste some of the wines from the wineries they visited.

The graduate student meet and greet with the CWSS-SCM Board of Directors was followed by a general Meet and Greet in the fover near the Registration Desk. Good company, a drink and good food was a great introduction to the meeting. As they registered, the guests could go and meet up with old friends and introduce themselves to new ones. A large variety of substantial snacks and finger food were provided: beef on a bun, cold canapés and hot hors d'oeuvres, crudités and cheese.

The President's dinner was an opportunity for the guest speakers of the plenary session to meet with the CWSS-SCM Board Executive, the chair of the LAC and the chair of the plenary session. The group were engaged in lively discussions related to the topics of the Tuesday session and to the work of the plenary speakers.

Plenary Session

On Tuesday morning, Peter Sikkema, President of the CWSS-SCM, and Clarence Swanton, chair of the LAC, welcomed attendees to the Annual Meeting. The topic of the Plenary Session was Herbicide Resistance

Shiona Glass-Kaastra, University of Guelph, Veterinary College, talked about antibiotic resistance, which parallels with herbicides. François Tardif from the University of Guelph discussed triazine resistance. Graminicide resistance (Acetyl-CoA Carboxylase Inhibitors) was Hugh Beckie's topic (Agriculture and Agri-Food Canada, Saskatoon). Mike Owen from Iowa Staté University gave his perspective on ALS inhibitors resistance. Glyphosate Resistance was covered by Jeff Stachler from North Dakota State University. Chris Hall, University of Guelph, reviewed resistance to HPPD Inhibitors. The session ended with Aaron Hager, University of Illinois, on resistance to auxinic herbicides.

Graduate Student Session

The afternoon session was the Graduate Student presentations. A total of 18 students presented their research:

- 1) <u>Kim Walsh</u>, University of Albeta (U of A)— First report of outcrossing in camelina [Camelina sativa (L.) Crantz], a potential platform for bioindustrial oils.
- 2) Zhenyi Li, Nova Scotia Agriculture College (NSAC) Hexazinone Alternatives for Wild Blueberry Production.
- 3) Goutam Kuwar, NSAC Weed management options for organic wild blueberry production.

- 4) Todd Larsen, NSAC Japanese knotweed (Fallopia japonica) in Nova Scotia: ecological impacts and management of an invasive weed.
- 5) <u>Eileen Beaton</u>, NSAC Wild Chervil (*Anthriscus sylvestris* (L.) Hoffm.) Management on Nova Scotia Dykes.
- 6) Margaret Eriavbe, NSAC Growth and vegetative characteristics of Hieracium pilosella L. (mouse ear hawkweed) and Hieracium caespitosum (meadow hawkweed) in wild blueberry (Vaccinium angustifolium) fields on Prince Edward Island.
- 7) Scott White, University of Guelph (U of G)— Emergence and development of red sorrel (Rumex acetosella L.) and wild blueberry (Vaccinium angustifolium Ait.) ramets in Nova Scotia.
- 8) <u>Breanne Laturnus</u>, U of A Pyroxasulfone and Sulfentrazone Control of Herbicide Resistant Weeds in Field Pea.
- 9) Rob Miller, U of G Weed Control and Cultivar Tolerance to Saflufenacil in Soybean (*Glycine max*).
- 10) <u>Sid Darras</u>, U of A Improving field-pea competitive ability using genotypic mixtures.
- 11) Julia Thompson, The University of Western Ontario The influence of glyphosate treatment on the growth and fitness of glyphosate-resistant and -susceptible giant ragweed (Ambrosia trifida L.) biotypes

- 12) Joe Vink, U of G, Ridgetown Campus Glyphosate-Resistant Giant Ragweed in Ontario: Distribution and Control.
- 13) Amanda Green, U of G Mechanisms of resistance to glyphosate in giant ragweed (*Ambrosia trifida* L.) in Ontario.
- 14) Megan MacEachern, NSAC Potential for spreading dogbane (*Apocynum androsaemifolium* L.) management with the dogbane leaf beetle (*Chrysochus auratus* Fab.).
- 15) Rhoda deJonge, University of Toronto Is it a 'dog' eat 'dog' world? -- "Will the native dogbane beetle adapt more quickly to dog strangling vine in restricted situations?"
- 16) Fawn Turner, U of G The recruitment biology and ecology of small and large crabgrass in turfgrass: Implications for management in the context of a cosmetic pesticide ban.
- 17) <u>Derek Lewis</u>, University of Manitoba Biennial Wormwood (*Artemisia biennis*) and Kochia (*Kochia scoparia*) Interference with Sunflowers.
- 18) <u>Eric Tozzi</u>, U of G Overwintering Survival of Canada fleabane (*Conyza canadensis*) in a Changing Climate.

Attendees to the student presentation session experienced a slight break to stretch their legs and take a break as a fire alarm interrupted the session. After the break, the talks continued without affecting the schedule.

Workshops

The workshops started with everyone attending the Crucial Conservations by Justin Hale on Wednesday morning.

Al Watson from the University of McGill, Pam Charbonneau from the Ontario Ministry of Agriculture, Food and Rural Affairs and Gerry Stephenson from the University of Guelph participated in the Symposium – Alternatives for Weed Management in Landscape Environments. The session ended with a panel discussion on the topics presented.

Four concurrent workshops were also held on Wednesday:

- Graduate Student Workshop. "So what? and Who cares? Making your science, media friendly." Owen Roberts, University of Guelph
- 2. Tillage the forgotten mode of action. Summary: With the increase in herbicide resistant weeds and weed shifts there is one mode of action that has never had a case of weed resistance; tillage. Mike Cowbrough and Greg Stewart (OMAFRA)
- 3. Smartphone Tips and Tricks. Summary: To-day's smart phones have the power of many personal computers and provide a number of practical tools to make the job of a crop consultant, research technician or

- professor easier. Ian McDonald, OMAFRA.
- CSI Crop Scene Inves-4. tigation: Handling the product inquiry. Complaint calls are never easy and can result in huge liabilities if handled incorrectly. What are the critical things to document? What service can a professional provide that leaves the grower with a positive experience? Steve Johns of Syngenta facilitated this workshop.
- **Program Sessions**

There were four program sessions this year:

- Weed Control in Corn, Soybean and Edible Beans Section, chaired by Peter Sikkema,
- Weed Biology / Ecology; Noxious / Invasive Weeds Control Section chaired by Darby McGrath

- Weed Control in Cereals, Oilseeds & Pulses Section - chaired by Bob Blackshaw
- Weed Control in Horticulture & Special Crops Section chaired by Rob Nurse

The Provincial Weed Reports and Regulatory Issues was chaired by David Ralph.

The poster session was organized by Diane Lyse Benoit before the meeting and by Eric Page at the meeting.

Conclusion

2012 Photo Contest—New Category2012 Photo Contest—New Category-Research in Action

Start gathering your photos or taking new photos for the 2012 Photo Contest. The photo categories have changed somewhat. Category 1 remains the same but categories 2 and 3 are combined and a new Category 3 is added.

<u>Category 1</u>: Agriculture and Forestry: individual botanical subject is not the prime theme of the image. For example: production (seeding, spraying, cutting...) or general views (landscape)

Category 2: Weeds: Pictures of plants (patches, whole individual or parts) considered as weed. Images should demonstrate morphologic characteristics and/or weed invasion/competition. For example, dandelion seeds transported by wind, vetch on evergreen, soybean field with common ragweed...

Category 3: Research in action: Pictures of research activity whether it be in the lab, or in the field. For example, canola breeding greenhouse, plot seeding, hand spraying...

Anne Légère, B.Sc., M.Sc., Ph.D.

Anne obtained her B.Sc. in Biology in 1974 and M.Sc. in Plant Science in 1979 at Laval University, followed by a Ph.D. in Weed Science in 1986 from Purdue University in Indiana. However, she has been employed with Agriculture and Agri-Food Canada (AAFC) at Ste-Foy, QC, since 1978, first as a Biologist, then as a Research Scientist in 1986. From 1993 to 1995, she was a Visiting Associate Professor in the Department of Plant Science at McGill University, Visiting Research Scientist at AAFC in Saskatoon from 1995 to 1997, then back to Ste-Foy until 2005; at that time she went back to Saskatoon where

she currently resides! Dr. Légère is a leader in the areas of ecological crop protection, weed ecology and management, and agroecological impact of cropping practices on weeds and biodiversity. For example, she has examined the sustainability and impact of transgenic, organic, and conventional cropping systems on biodiversity, as well as weeds as indicators of agronomic and climate changes. In addition, she has contributed to the training of graduate and undergraduate students as future leaders in weed science. She is actively involved in the European Weed Research Society and International Weed Science Society, past Director of Publications for the Québec Society for the Protection of Plants, past Director of Publications and a Fellow of the Weed Science Society of America, and past President of the Canadian Weed Science Society. In 2008, she was honored with the *Excellence in Weed Science* award by the Canadian Weed Science Society for her outstanding career accomplishments.






Major changes to Topics in Canadian Weed Science

After several months of consideration and negotiations with the Agricultural Institute of Canada (AIC) and the Canadian Journal of Plant Science (CJPS), the CWSS/SCM Board of Directors has made arrangements to begin publication of the proceedings of the annual plenary sessions (a.k.a., the Symposium Monographs) as papers in CJPS rather than as annual volumes of Topics in Canadian Weed Science. There are a number of reasons for this change. Partly it is to support CJPS (of which CWSS/SCM is a sponsoring society), partly it is to provide better dissemination of weed science information (a society goal), and, to a lesser extent, it is economic. Publishing via the CJPS route will realize a modest saving, which is intended to be utilized toward improving the quality of

the plenary sessions and other society services.

Currently, it is planned to commence CJPS publication with the plenary session at the 2012 meeting. Although the option for publishing the presentations collectively as a special issue of CJPS was considered, it was decided to insert individual presentations as separate papers scattered through the journal as soon as they are ready for publication. This strategy will ensure the most timely distribution of information. In addition, the Board has secured an agreement with AIC that these papers will all be freely available to everyone as "open access" papers at the CJPS website. It is planned that links to these papers will also be provided at the CWSS/SCM web site.

It is anticipated that not all presentations at the plenary sessions will be of a nature suitable for presentation in the peer-reviewed CJPS. The Board is exploring other options for making such presentations available to meeting attendees. This new strategy does not necessarily mean the end of *Topics in Canadian Weed Science* as a publishing vehicle for the society.

There are potentially many other projects for which it could be put to service as an irregular publication. The Board is eager to hear of any ideas, concerns or proposals from the membership at large.

Denise Maurice was one of the most influential and important members of the weed science community in the last generation. The Canadian Weed Science Society would like to recognize her contributions to weed science with a brief biographical sketch that will allow others to better appreciate the scope of her influence during her life and career.

Denise was born in Prince Alberta, SK on April 10 1955. She received a Bachelor of Science degree in agriculture from the University of Manitoba in 1977, majoring in plant science, and a Master of Science degree in 1985, majoring in weed science (under the supervision of the late Dr. Ian Morrison). Her two major interests in life were her children, Evan and Elise, and her work.

Denise was CWSS-SCM President in 2005 and a CWSS – SCM Outstanding Industry Member award winner in 2001. She went on to receive the Premier's

Award of Excellence in 2004, the WSSA Outstanding Industry Award in 2007, and the Farm Tech Recognition Award for her outstanding contribution to Alberta's cropping industry in 2009.

Denise held various roles in government and industry, with her most recent role as Vice President, Crop Production, in the Canola Council of Canada. As the provincial weed extension specialist for Alberta Agriculture in the late 1980s and early 1990s, Denise established herself as one of the most dynamic individuals the weed science community had ever seen. She networked far and wide, striving to obtain the best information for her clients and advocating for research where she felt it was necessary. She became well known on the extension speaking circuit, and amazed her audiences with her breadth and depth of knowledge on a large variety of topics, which she always delivered with her trademark enthusiasm. During this time, she was instrumental in developing a herbicide resistance action plan for Alberta, and initiating the first herbicide resistant weed survey in Alberta. In 1993, she played a major role in organizing the first ever national CWSS (then Expert Committee on Weeds) conference, and the first Canadian symposium on weed resistance to herbicides, both of which were held in Edmonton.

After joining Westco in the mid 1990s, Denise built on her skills to supervise and train her staff to become what she wanted - the best in the business. Out of that time came several products such as the AgroManager program, which among other things incorporated the concept of economic thresholds for weeds, insects, and diseases of crops. This innovation earned her the Canadian Agri-Marketing Association's first prize, Electronic Media Outbound, in 2000. Denise also used her influence and budget within the company to support needed research. Much of the new, innovative information that came forward from the research community during that time had the support of Westco, or more specifically, Denise.

In 2004, the CWSS-SCM elected Denise as our president, the first woman, and the first industry member to lead our society. Her enthusiasm and positive energy never waned, she never stopped working hard, and she carried us along with her. She died unexpectedly on November 23, 2011. Her mark on us, as professionals and as friends, will never be forgotten.
